Chief Bank discussed the purchases of two (2) Type I Wheeled Coach ambulances. Chief Bank explained the need for the ambulances and discussed the configuration that the District was using to provide ambulance service. He also shared that pricing had been verified through HGAC and that the acquisition and financing had been discussed with District counsel.

Mr. **Fossum** made a motion to proceed with the purchase of two (2) Type I Wheeled Coach ambulances, but requested that Mr. Majeres with Ubernosky & Majeres, PLLC, the District's accountant, review whether the purchase should be financed or paid from the District reserves. Mr. **Fleming** seconded the motion. The motion passed 4 to 0.
