

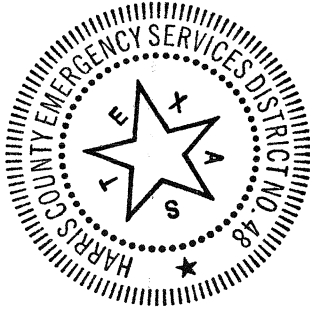
NOTICE OF PUBLIC MEETING

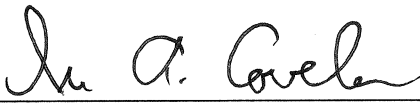
The District will consider and act upon the following matters:

6. To review, discuss and take action on funding the District's payroll obligations.
7. To review, discuss and take action regarding matters related to the District's depository banks.
8. To review and take action on minutes of prior meetings.
9. To review, discuss and take action regarding matters related to dispatching the Department to calls for service.
10. To receive any reports from Fire Chief George McAteer and take any necessary action related to his report.
11. To receive an EMS division report from Assistant Chief Eric Bank and take any necessary action related to the report.
12. To receive a Fire division report from Assistant Chief Brett Ellis and take any necessary action related to the report.
13. To receive an administrative report from Assistant Chief Ray Sidwell and take any necessary action related to the report.
14. To receive a quarterly facilities maintenance report from Division Chief of Logistics Mabelle Richter.
15. To receive any reports from the District's Business Manager and take any necessary action related to the report.
16. To receive an equipment, apparatus and facilities report and take any necessary action related to the report.
17. To review, discuss and take action regarding adopting a new compensation schedule for the District's employees.
18. To review, discuss and take action regarding adoption and amendment of District policies, standard operating guidelines or job descriptions.

19. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.

To discuss any new items which need to be on the agenda for the subsequent District meetings and approve the proposed meeting dates for the bill pay meeting to be held on Wednesday, September 1, 2021 at 6:00 p.m., and the regular monthly meeting to be held on Wednesday, September 15, 2021 at 6:00 p.m.
21. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel.
22. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
23. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
24. To review, discuss and take action regarding any District personnel matters.
25. To review, discuss and take action regarding District real estate matters.
